

CLICK 2.0 PHOTO AND VIDEO COMPETITION TERMS AND CONDITIONS

- The Click 2.0 competition is organised by Cotton Australia Limited (ABN 24 054 122 879), Suite 4.01, 247 Coward Street, Mascot NSW Australia 2020
- Each entry must be submitted in accordance with these terms and conditions and by entering the competition, the entrant agrees to be bound by these terms and conditions. There is no cost to the entrant to enter.



Dates

- Entries will be accepted until 11.59PM, June 8, 2018. Entries received on or after June 9, 2018, will not be accepted and no responsibility will be accepted by Cotton Australia for lost, late or incomplete entries

Categories

1. **Aussie cotton people**
 - Photos of people using technology and equipment, portraits, working as a team and working safely
2. **Aussie cotton landscapes**
 - Photos of the plant, fibre, aerial shots, landscapes and the farm across different times of day and different times of the season
3. **The moving image**
 - Video footage of no more than 2 minutes (this may include video of people working in cotton, landscape shots, harvesting in the field, at the gin, and so on; we are seeking raw footage, not a short film; music overlay may be included)

Eligibility

- Entrants must be 16 years or older at the time of entry
- Entries must feature Australian locations
- Entries must adhere to workplace health and safety (WHS) guidelines and depict safe practices
- Entries must be free from watermarks
- Photo-shopping and other forms of photo/video editing and enhancement are permitted
- Composite images (picture that is made from the combination of multiple images merged into a single surface) will not be accepted
- Entries must be submitted in JPEG (photo) format and each photo should be no larger than 10MB. Please email photo entries to comp@cotton.org.au and email us for more info on how to submit videos (must be WMV)
- Any entry that was entered into or has won a prize previously in any competition run by Cotton Australia is not eligible to be entered into Click 2.0

Entry requirements

- Entries must be emailed to comp@cotton.org.au alongside the following information:
 - Entrant's full name
 - Entrant's postal address, email address and preferred telephone contact number
 - The category entered for each entry
 - A caption for each entry (no more than 20 words per entry)

Moderation

- Prior to being judged, each entry will be moderated by Cotton Australia and the decision by Cotton Australia to accept or reject an entry is at Cotton Australia's sole discretion and no correspondence will be entered into
- Entries deemed by Cotton Australia to depict illegal, unethical or unsafe practices will not be accepted

Consent

- In submitting an entry, the entrant is deemed to have the consent of any person/people pictured
- Entries featuring children must have the consent of the child's parent or guardian
- Cotton Australia reserves the right to refuse entry where it deems privacy rights have been compromised

Usage

- Cotton Australia is granted usage of each entry for purposes determined solely by Cotton Australia, in perpetuity, and without notice and without any fee paid to the entrant
- Entries may be used at any time by Cotton Australia to promote the competition
- Usage will not be of financial or commercial benefit to Cotton Australia
- Usage of entries may be in full or in part and may include, but will not be limited to, print, publications, display at events, conferences and exhibitions, digital and social media platforms, and competition promotional activities
- Where possible, entrants will be publicly credited when entries are used, however this is not guaranteed
- Cotton Australia may contact entrants to obtain higher resolution images if available

Copyright

- Entries must be original and must not infringe any party's intellectual property rights or copyright
- Entrants retain copyright of their entry

Judging

- A judging panel, consisting of one photographer and one industry representative, will select the winning entries and people's choice finalists
- Cotton Conference delegates will have an opportunity to vote for the people's choice category
- The 12 best entries (4 entries from each category) will be determined by the judging panel and will be displayed at the 19th Australian Cotton Conference to be held from August 7-9, 2018, at the Gold Coast Convention and Exhibition Centre, Broadbeach, Queensland
- Eligible entries will be judged on the basis of originality, character and creative merit, story-telling and technical photography/videography ability/skill
- The discretion and decisions of the judges is final and no correspondence will be entered into

Prizes

- Chance plays no part in determining the recipient of each prize
- Recipients will be awarded:
 - First Place: \$4000 camera equipment voucher
 - Runner Up: \$1500 camera equipment voucher
 - Category winners: \$500 camera equipment vouchers (one per category)
 - People's Choice: \$1000 camera equipment voucher
- In the event the prize is unavailable or cancelled for any reason whatsoever, Cotton Australia reserves the right to substitute alternative prizes of similar value. Competition prizes cannot be redeemed as cash.
